The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you to compare it with other products.

Comprehension alert: You are about to purchase a product that is not simple and may be difficult to understand.								
What is this product?								
Type	Partnership interests in NIO Global Infrastructure I Feeder K/S (the “ Product ” or “ NIO NGI I ”), which is organised as a Danish limited partnership. The Product qualify as an alternative investment fund in accordance with Directive (EU) 2011/61.							
Term	The Product has no maturity date. NIO is not entitled to terminate the Product unilaterally, but the retail investors cannot prevent the Product’s termination, which is to be decided at a general meeting of NIO NGI I. NIO NGI I is expected to have been disposed of its investments by around the end of 2035 with an extension option for additional 3 years. The Product is expected to mature upon the maturity of the Underlying Investments or upon NIO NGI I’s disposal of its investments.							
Objectives	NIO NGI I is a feeder fund to NIO Global Infrastructure I SCSp (jointly referred to as “ NIO NGI I SCSp ”), which is a fund-of-funds managed by Nordic Investment Opportunities A/S, which has been authorised as manager of alternative investment funds by the Danish Financial Supervisory Authority. NIO NGI I SCSp invests in infrastructure funds with investment strategies within infrastructure, including by direct fund investments and co-investments with other alternative investment fund managers. The objective of NIO NGI I SCSp is to generate an aggregated return for the investors through 6 to 10 investments in infrastructure funds or co-investments with managers of alternative investment funds with infrastructure-related strategies (the “ Underlying Investments ”). The return on the Product depends on the return generated by the Underlying Investments.							
Intended retail investor	The Product is offered to investors defined in section 5(5)(i)-(ii) of the Danish Act on Alternative Investment Fund Managers, etc. The Product is intended only for retail investors with sufficient theoretical knowledge of and past experience with infrastructure or private equity funds who can bear the loss of their investments with a long investment horizon and who can accept that it is not possible to cash in the partnership interests from time to time.							
Redemption	It is not possible to demand that the Product be cashed in, and the Product is generally non-transferable.

<p>The risk indicator assumes that you keep the Product for the entire expected term, which is expected to be approximately 12 years, and which may be extended by up to 3 years. The risk of the Product may be considerably higher if the Product is not held throughout its term. The Product is non-liquid. The summary risk indicator is a guide to the level of risk of the Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets or because we are not able to pay you. We have classified the Product as 6 out of 7, which is the second highest risk class. This means that potential losses on future performance are assessed to be at a high level, and poor market conditions will very likely impact the capacity of the Product to pay you.</p> <p>Please be aware of currency risks: The Product is denominated in EUR, while the Underlying Investments may take place in companies that are exposed to currency risks. The final return you receive depends on the exchange rate between the two currencies. The above indicator does not take this risk into</p>								

account. The risk profile of the Product reflects the risk of the underlying indirect investments, including macro-economic, political, financing and currency risks of investments in private equity and private equity-related activities. This Product does not include any protection from future market performance so you could lose some of or your entire investment.

This table shows the money you could get back over 12 years under different scenarios, assuming you invest EUR 10,000. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The calculations of performance scenarios are based on an investment commitment of EUR 10,000 with an assumption of all EUR 10,000 having been invested from admittance to NIO NGI I and that the return on such amount corresponds to the expected net IRR of the Product based on ongoing capital contributions of the minimum commitment amount to NIO NGI I.

Typically, commitment-based investments like NIO NGI I will involve ongoing capital drawdowns throughout the investment period of NIO NGI I and the Underlying Investments. As the Product cannot be cashed in and retail investors only in exceptional cases will be ordered to sell their partnership interests during the holding period, only scenarios at the end of the holding period are included. The scenarios presented are an estimate of future performance based on evidence from the past for similar investments showing how the value of this investment varies and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the Product.

The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you. The Product cannot be cashed in. This means that it is difficult to estimate how much you would get back if you cash in before maturity. You will either be unable to cash in early or you will have to pay high costs or make a large loss if you do so.

The figures shown include all the costs of the Product itself but may not include all the costs that you pay to your advisor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What happens if NIO is unable to pay out?

Retail investors may suffer financial losses in case of NIO's breach of its obligations to NIO NGI I as this may adversely impact the development of the Product. Retail investors may suffer financial losses in the event of a negative development of the Product, which results in NIO being unable to pay out. No such losses are covered by any kind of investor compensation or guarantee schemes. Retail investors may potentially lose their entire investments.

What are the costs?

The annual reduction in yield (RIY) shows the impact of the total costs on the expected return on the Product. The total costs are one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the Product itself at the end of the holding period. The calculations include both costs of the Product itself and the Underlying Investments. The figures assume you commit EUR 10,000. The figures are estimates and may change in the future.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the Product and how well the Product does. The amounts shown here are illustrations based on an investment amount of EUR 10,000. We have assumed that the Product performs as shown in the moderate scenario.

(*) This illustrates how the costs reduce your return each year over the holding period. For example, it shows that if you exit at the recommended holding period your average return per year is projected to be 12.07% before costs and 7.87% after costs.	

Cost composition

The table below shows the impact each year of the different types of costs on the investment return you might get at the end of the holding period and the meaning of the different cost categories.

Entry costs	The cost consists of the amount you pay at the beginning of the investment in the form of the Upfront Fee and the AIFM Fee. The maximum amount you will be charged will be equivalent to 1% of your capital commitment as a one-off payment and 0.1% of the Fund's total commitment in Year 1. Your Subscription Application will provide details of the applicable fee for your particular investment.	0.14%
Exit costs	Exit costs are not relevant as they do not apply if you keep the product for the recommended investment period. No exit costs are anticipated, as any costs incurred in connection with the early redemption and repurchase of partnership interest during the investment period will be borne separately by the investors involved.	0.00%

Management fees and other administrative or operating costs	The cost consists of ongoing operational costs associated with management of the Fund. This includes costs relating to fund administration, depositary, audit and similar administrative costs. It also includes other costs, consisting of the AIFM Fee, Management Fee to NIO and the Management Fee to the managers of the fund investments. This is a %-wise estimate based on the expected costs.	3.69%
Transaction costs	This is an estimate of the costs associated with the Fund's investments. The cost covers the estimated cost of legal and tax due diligence. The actual amount will vary depending on how much the Fund buys and sells. The cost is covered by the Management Fees received and is not charged separately.	0.02%
Incidental costs taken under specific conditions		
Performance fees (carried interest)	NIO does not receive any carried interest or other performance fee on fund investments. For Co-Investments, NIO receives a carried interest equal to 10% of the potential excess yields available after the total aggregate capital contributed by the partnership to the Co-Investment has been returned and the Partnership has received a Preferred Return equal to 6% IRR p.a. The managers of the fund investment receive carried interest on the investment results of the investments, which is deducted from the return. The actual amount will vary depending on the performance of the investment. The managers will typically receive 20% carried interest from the time when the IRR of the Master Fund exceeds 7-8%. The estimate of aggregate costs presented is based on historical data.	0.35%

How long should I hold it, and can I take my money out early?

The Product has a holding period of approximately 12 years and is intended for retail investors with a long investment horizon. No option is offered to cash in or sell back the partnership interests from time to time during the holding period. The partnership interests are generally non-transferable.
